PMP Peeling Mint Professional pH (0,5 – 0,8)



PMP PEELING MINT PROFESSIONAL, is a chemical peel based on TCA (trichloroacetic), with an acid concentration of 26%. It is bio revitalising and skin rejuvenating, with freshness effect (MENTHOL) that makes the treatment more comfortable.

INDICATIONS

PMP PEELING MINT PROFESSIONAL, thanks to the activity of its active ingredients, allows treating those skins that are chrono-aged and photo-aged successfully. The exfoliating action of the acid cocktail is completed with the powerful activity provided by the rest of the active ingredients, promoting tissue regeneration, cell renewal, the replacement of structural proteins and the restoration of the optimal physiological condition of the skin.

- It reduces blemishes.
- It reduces wrinkles and expression lines.
- It provides a tightening effect (botox-like, decontracting).
- It brightens intensely (extra supply of natural light to the skin).
- It smoothes the pore.
- It homogenises the texture of the skin.
- It reduces the skin imperfections resulting from scars (acne...) and stretch marks.

INGREDIENTS

Aqua, propylene glycol, trichloroacetic acid, malic acid, lactic acid, glycolic acid, tranexamic acid, salicylic acid, panthenol, betaine, sodium PCA, acetyl hexapeptide-8, menthol, polyquaternium-7, disodium EDTA, caprylyl glycol.

HOW TO USE

- 1 Cleanse the area to be treated carefully before the application of the product, and remove make-up, if necessary.
- 2 Protect the eyes with some cotton pads moistened in water and the lips, wings of the nose and tattoos or micropigmentation with a moisturising cream.
- 3 Extract 2.5 ml of product with a 19 G needle, remove the needle and apply the product with nitrile gloves or a fan brush.
- 4 Massage until absorption (7-10 min). Once it is absorbed, leave on for 3-5 min. According to professional criteria based on the type of skin and tolerance of the patient. The product causes a burning sensation and skin redness.
- 5 Rinse with cool water, never hot, with soaked gauzes, cotton pads or cloths. Rinsing the product with water may cause a reactivation of the peeling, bringing a sensation of heat and burning, which calms down as the product is removed.
- 6 Finish with moisturisation and nutrition as well as very high photo protection.

Check with the professional protocols.

Apply **once every 1 or 2 weeks** for a total of **4-6 sessions**, according to professional criterion and the intended objective. The **days following** the treatment:

-Ensure a **good skin moisturisation and nutrition** in home care and maintenance. **Drink between 1.5 – 2 L of water a day.**

-**Avoid** direct sun exposure, as well as solarium sessions, during the following days.

-Protect the skin against sun rays (10 - 15 days). Before going out, apply **very high photo protection**.

It may cause a slight peeling after 48-72 h, especially if there is not proper moisturisation during these days.

CONTRAINDICACIONES

- Do not apply to the eyes, lips, or mucous membranes.
- Do not use in pregnant women or breastfeeding mothers.
- Do not use in people with autoimmune pathologies, skin diseases, herpes, severe active inflammatory injuries, etc.
- Do not apply in case of confirmed or under suspicion hypersensitivity to any of the components of the product (see the list of ingredients). Carry out a sensitivity test.
- Avoid irritating actions and products.
- Avoid high body and environmental temperature, reduce – freshen.

PRECAUTIONS

- If the area happens to show a more intense activity during the time of exposure of the chemical peel, proceed to neutralise the area with neutralising solution or water, leaving the rest of the applied area on.
- In case of unbearable irritation, wash with plenty of cold water for 10-15 minutes. If irritation continues, medical measures will be required.
- Store in a cool place, protected from light and away from heat sources.
